

| Competition format: | Main Draw: Pool play (4 groups with four teams, from quarterfinals single elimination) Day 1: - 1 st & 2 nd round of Pool Play Day 2: - 3 rd round of Pool Play - Single elimination: Quarterfinals, Semifinals and Finals (bronze and gold) |
| Teams main draw: | 16 teams directly qualified (2 teams per country): • 4 teams host country • 2 teams per country per category from each other MEVZA National Federation |
| Technical meetings: | Preliminary Inquiry Main Draw (Men & Women) - Sunday Evening at 8pm. |
| Main draw date: | Arrival: U20: Sunday, July 9, 2017 (afternoon, check-in after 15h) Main Draw: U20: July 10-11, 2017 (Monday-Tuesday) |
| Delegation: | 1 official per 2 teams |
| Accreditation: | Organizers will provide all Organizing Committee members, Officials, referees, players, coaches, physiotherapists, VIP's, journalists, technical staff, court personnel, volunteers, etc. with official accreditation cards and will ensure that only those people will access the designated venue areas. |

| Travel Costs: | Each team bears its own return travel expenses to the official competition venue. The Organizing National Federation must provide and bear the costs for the transport of the visiting teams from the nearest airport to the official competition venue as well as a local transportation. |
| Food & Lodging: | Each Federation shall pay 50% of the "unique fee" to MEVZA for each member of its delegation (max. 2.5 people per team): • € 50. - for 2 nights and full board per person MEVZA will cover the remaining 50%, paid directly to the organizer (only for the 1 st 2 teams per country per gender) |
